*For all journeymen, apprentices, and tradesmen, the Savings & Organizing Fund deduction is \$2.88 per hour from the Taxable Base. The Savings deduction is \$2.20 per hour, and the Organizing Fund is \$.68 per hour, both of which are made from the Taxable Base rate of pay. For Helpers, only an Organizing Fund deduction of \$.18 applies.

The current IRS Mileage rate is \$.535 per mile.

The Journeyman Total Package wage will \$1.65 on May 1, 2018.
