\*The Taxable Base Wage Rate includes a \$2.58 deduction for journeymen (\$1.58 for apprentices) for Vacation pay and Organizing. The vacation pay deduction is \$2.00 per h journeymen (\$1.00 per hour for apprentices), and \$.58 per hour for Organizing for both journeymen and apprentices. For Preapprentices there is a \$.23 deduction for Organizi deduction for Vacation for a total deduction of \$.23.

Industrial work is defined as work in mining operations, paper and pulp operations, and power plants. It involves only the process related sheet metal work. It does not include heating, or air conditioning for comfort or service work on the same. It also does not include architectural sheet metal, siding or decking in or on mining operations, paper and operations, and power plants.

SASMI NOTE: The SASMI rate for Foreman and General Foreman are the same as the rate for Journeymen and there is no longer a different SASMI rate for overtime hours on any classification. All SASMI hours are paid at the straight time rate.

The Journeyman Total Package will increase \$1.55 effective May 4, 2015.

The current IRS mileage rate is \$.56
